As demonstrated by the University of Alberta letter of admission submitted with the application for a study permit, Mohammed Abdul Khader Lnu has been admitted to the Masters of Public Health (MPH) for Fall 2023.

This letter is to provide context to the University of Alberta's MPH admission decisions and to support the student's application for a study permit. The MPH is an extremely competitive program. Given the limited number of seats that are available each year we only admit approximately the top 10% of applicants. In 2022 we had 80 students join the program from an applicant pool of 500.

There is great interest in the MPH program given our current environment to find solutions to complex problems that defy single sector solutions/actions and given that the program at the University of Alberta is only one of very few programs accredited by the Council for Education on Public Health. The MPH is a professional degree, and the pool of applicants is diverse, including those with medical, engineering, nursing, and other degrees. In addition, students with other advanced graduate education (MSc, PhD) enroll in the Master of Public Health program to ensure they have a solid foundation in public health issues.

The career opportunities for our graduates are significant both within Canada and their home countries. The training students receive at the University of Alberta ensures they are prepared to make valuable contributions to their communities. We understand that IRCC officers need to be satisfied that students will leave Canada if their study permit expires. There are many immigration pathways that encourage students to remain legally in Canada upon conclusion of their studies and it is hard to imagine that any student with such sought after qualifications as a MPH would jeopardize their career prospects by remaining illegally in Canada at the conclusion of their study permit.
